Applications are invited from intending eligible candidates who are citizens of India within the age limit 18 years to 40 years as on 01.01.2023 (relaxation as per existing government rules) for filing up the following Grade IV post in the establishment of the Chief Judicial Magistrate, Dhubri, Assam in the Pay Scale as shown below:-

### **HOW TO APPLY:-**

**1.** The filled up application must be submitted in Standard Form (published in the Gazette Part IX of Govt. of Assam) and accompanied by the following:-

- i) Self-attested photo copies of testimonial/certificate in support of his/her age, caste, educational qualification, experience certificate (if any), employment exchange registration card etc.
- ii) Three copies of recent passport sized coloured photographs with signature on the reverse side.
- iii) Mobile Number along with E-mail ID (if any) must be mentioned in the Standard Form.
- iv) The name of the candidate must be registered in the Employment Exchange and valid Employment Exchange Registration number is to be mentioned in the application form.

- v) The applicant has to furnish a self declaration certificate along with the application form mentioning that **he/she has not passed HSSLC or Class-XII or equivalent examination or above.**
- vi) Candidates already in Govt. Service must apply through proper channel along with "No Objection Certificate" from the appointing authority.
- vii) The envelope containing the application should mention the name of the Post indicating "**Application for the Post of PEON**" super scribed on the top of the envelop.
2. The applications in sealed envelope can be submitted through **post** or directly in the "**drop box**" of the office of the Chief Judicial Magistrate, Dhubri.

#### **TERMS AND CONDITIONS**

4. The last date of receipt of application is **15.03.2023** till **05:00** PM and application received thereafter, (in any mode) shall not be accepted.
5. Incomplete application in any respect or late received applications shall be summarily rejected without notice.
6. If the candidate is found to suppress his/her educational qualification or furnish any wrong information at the time of applying for the post, his/her candidature shall be liable to be rejected without any notice.
7. If any candidate is found canvassing directly or indirectly, his/her candidature will be rejected.
8. The applications not fulfilling the eligibility criteria shall be rejected without any notice.

#### **SELECTION PROCEDURE:-**

The candidates will have to appear in an Interview (viva-voce) at their own expense. No TA/DA shall be admissible for appearing in the Interview. The selection will be made purely on merit basis.
