Applications are invited from the eligible citizen of India in Standard form with attested copies of all relevant documents/testimonials in support of education and other qualifications including experience certificate if any with 3 (Three) copies of duly signed passport photograph should invariably be enclosed with application as prescribed in Assam Gazette of Part-IX for filling up the following Grade-IV post in the establishment of the undersigned carrying pay in the **PB : 12,000/- to 52,000/- + Grade Pay Rs. 3,900/-** and other allowances as admissible.

Reservation category : **UR (Unreserved)**

Eligibility Criteria :

1. The age of the candidate should be not less than 18 years and not more than 40 years of age as on 01-01-2023. The relaxation in the upper age limit of reserved categories shall be given as per existing Govt. Rules.
2. The Candidate must have minimum educational qualification of Class- VIII passed and not more than HSLC passed.
3. The name of the candidate must be registered in the District Employment Exchange.
4. Extra Curriculum of the candidates will be given due weightage.
5. Incomplete applications as well as candidates not fulfilling the eligibility criteria shall be rejected without any notice. No application will be entertained after the last date fixed.
6. List of eligible candidate alongwith specific date of interview(Viva-voce) only shall be notified in the official website of the Dhubri District Judiciary(www.dhubrijudiciary.gov.in) as well as in the notice board of the office of the Member ,Motor accidents claims Tribunal, Dhubri in due course.
7. Canvassing by any means will immediately lead to rejection of candidature.
