 - e) Copy of GST registration certificate.
 - f) Copy of Savings Bank Passbook having SB A/c No.
- 4) Rates should be quoted both in words and figures excluding Taxes / GST. TAX / GST is to be shown separately against the item in the bills, where applicable, which will be deducted at source. The firm should quote rates for each item which are mentioned in the item list provided along with the quotation, without adding any extra item.
